1. February, 2006 Meeting Minutes

2. Treasurer's Report (February -2006) – Pete Dieringer

3. Athletic Director Report – Jim Okler

- **Summer Golf Outing**
 - **Mr. Okler notified the group that he would be unable to continue as the chairperson for the event. After discussion it was decided, that since no contracts had been signed, to cancel the golf outing.**
- **Fund Raising**
 - Mr. Okler presented draft of approval process for initial athletic team fundraiser.
 - Direction is to allow one fundraiser per group per year
 - Fundraisers cannot "underwrite" participation fees
 - Second fundraiser allowed with "collaboration" of Booster Club
 - **Lengthy discussion on proposal and impact on Boosters**
 - **Indication that Boosters do not want/have the ability to take on financial reporting and tracking of individual fundraisers.**
 - **Impression that, as discussed in earlier meetings, the responsibility for monitoring fund raisers has merely been shifted from the athletic department to the Boosters Club.**
 - **Additional discussion will be needed before Booster Club will agree to accept additional fund raising responsibilities.**
 - **Discussion on ability of school administration to monitor groups operating outside of the athletic department.**
- **Federal Grant**
 - Awaiting confirmation from DTE on status of grant. Will update at next meeting. Matching grant already approved by Boosters in February.

 - Parents Meeting scheduled for March 30 at 6:30 pm
 - Mr. Okler reviewed post season playoff results
 - Cheer team finished 8th in State
 - Two figure skaters competing in individual championship

 - Agreement reached on allowing track program to use increasing ad sales as fundraiser. Track program to keep 75% of all **new** program ads generated.
